**2) Which organizations are eligible to get affiliation with Textile Sector Skill Council (TSC) as Training Partner for job roles in Mill Sector?**

Only the following are eligible to get affiliation with TSC as Training Providers for job roles (mentioned at 1) above) in Mill Sector

- a. Textile mill in running production
- b. Textile machinery manufacturers including technical textile machinery manufacturers
- c. State/Central government recognized textile organizations Registered Textile industry associations in existence for past three years
- d. UGC/AICTE recognized institutes offering textile programs

**3) What if our organization does not fulfill the above criteria but has tie-ups with organizations/textile mills working in the relevant sub sector?**

Organizations not fulfilling the criteria mentioned at 2) above **but having tie-ups with organizations/textile mills working in the relevant sub sector** are not eligible for affiliation with TSC for textile mill Sector job roles as training providers/training centers. in the interest of candidates (trainees).

**4) Our organization is SMART affiliated TP and has conducted trainings in various**

sectors under PMKVY and we wish to apply for Textile Mill Sector Skill Trainings under TSC. We have/can arrange for Tie ups with Textile Mills.

Organizations not fulfilling the criteria mentioned at 2) above are not eligible for affiliation with TSC for Textile Mill Sector job roles, in the interest of candidates (trainees).

**5) What are the additional documents required for affiliation with Textile Sector Skill Council?**

In addition to those mandated by SMART/NSDC, the Copy of the following documents are required for affiliation with Textile SSC,

**6) What is the infrastructure, lab and equipment trainer and requirements specified by TSC for each of the job roles for the center validation?**

**7) What is meant by machinery in “Running Production Condition”?**

It means that the machines must be in a running Textile Mill in regular use for producing textile goods (fabric/dyeing), running efficiently and loaded with sufficient raw material for bulk production and it must be installed firmly on floor with a solid foundation, to avoid vibrations when the machine is under running production.

**8) What are the general requirements (infrastructure, equipment and others) specified by NSDC for training center affiliation?**

**9) Is it mandatory to have a Placement Co Ordinator for Training Center (TC)?**

Yes, it is mandatory to have a full time Placement Co Ordinator for each TC.

**10) My Training Center is constructed with Clay roof tile. Will my center qualify for infrastructure facility?**

No, your center will not qualify for infrastructure facility. TC should be constructed with RCC roof/ Asbestos roof for textile mills. Further details available on

**11) What is AEBAS?**

It is Aadhar – Enabled Biometric Attendance System this is mandatory for a TC to have this to monitor the attendance of all trainees.

**12) Is it mandatory to have a TSC certified trainer for the respective domain job role?**

Yes, it is mandatory to have all the trainers conducting training to be certified by Textile SSC for the respective domain job role.

**13) Is it mandatory to have a certified trainer for Entrepreneurship by NIESBUD?**

Yes, it is mandatory to have at least one trainer certified in Entrepreneurship by NIESBUD or any similar agencies specified in the scheme.
